




We look forward to serving and celebrating you in 2022.




TrustBridge is developing a growing network of mission-aligned charities and foundations in countries all over the world. As our network grows, our ability to give effectively and efficiently grows as well.



SAHAARA CHARITABLE SOCIETY

Sahaara Charitable Society was founded in 1994 with an express purpose to "fulfil dreams of the vulnerable and marginalised in society". Sahaara works in Mumbai (India) and its adjoining districts among children in providing education support and "safe hostels", as well as providing "reintegration" services to commercial sex workers and released prisoners.



"In the last two years the pandemic in India greatly impacted our project participants from the red-light districts. We provided emergency food reilief kits, trauma counselling, Covid protection gear to Corona warriors and medical equipment to strengthen the oxygen infrastructure in overburdened hospitals in rural India. We provided food security to 49,368 individuals across the country."

Somebody Cares is a registered Christian community-based organization based in Lilongwe, the capital city of Malawi. Our response is to the HIV/AIDS pandemic and the ravishing effects of poverty, providing comprehensive and integrated care and support. We are motivated and challenged by God`s command to the Church for righteousness and justice.



Chikondi is 3 years old. She received the first blanket ever in her family. They, like so many others in rural communities, cannot afford to buy blankets and sleep using sacks, or threadbare cloths - no match against the bitter cold. Last year, Somebody Cares made a difference by distributing 2,413 blankets to widows, critical patients, and children.

"The Gift of Love" helps the poorest of the poor in remote villages in Mongolia. These are often widows who find new hope in life and hear of the Hope of Christ. Every dollar we receive goes directly to buy sheep for these desperate people with no administrative costs.



The Gift of Love has given over 8,000 sheep to very poor people in remote areas. This project is special because every dollar we get actually goes to buy sheep for these widows and widowers and other poor and disabled. We administer it through other projects. It truly changes whole communities as they also catch the vision of generosity.

Community House Damaris operates a safe house in Athens, Greece offering long-term recovery programs for women and their children who have been or are at risk of sexual exploitation or trafficking. The women receive care in mental health, personal development, vocational training, and other services.



Community House Damaris works with a diverse array of women from various cultural backgrounds, but takes on cases with the singular goal of providing an atmosphere that facilitates long-term resoration. The services offered have been tailored to, but are not exclusive to, women who are considered of refugee status, internally displaced, or stateless and those who are pregnant or single mothers.

Life is a series of journeys—transitioning from childhood to adulthood, embarking on an education, entering the workplace—and with each journey, relationships are built, and lessons are learned. One of the founding members of the Kaiārahi Trust realized that the path to generosity is also a journey.





Robert Reid is a man who is not afraid to launch into unknown territory. Guided by a sense of conviction and purpose, he has carved an unusual path through life that has led him from mechanical engineer to church pastor, music festival business manager, developer, and entrepreneur to his current mission: to empower generous Kiwis to discover their own unique path on the journey of generosity through the Kaiārahi Trust.

"Throughout my career, I had the opportunity to build relationships with generous donors and families of significant means," says Robert. "What I realized was giving away money isn't as simple as it sounds. Many donors felt isolated. I really felt challenged to start a new platform that would provide a safe space for donors to dream and collaborate."

So in 2020, the idea for Kaiārahi Trust Donor Advised Fund (DAF) was born when Robert joined forces with two well-respected figures in New Zealand's Not For Profit sector—lan Kuperus, founder of Wilberforce Foundation, and David Mclay, barrister and charity law specialist.

"Just like the ancient 'Kaiārahi,' or navigator, guided the Maori canoes through uncharted waters of the Pacific using the stars," Robert says. "We felt called to help donors navigate the unknown landscape of charitable giving and champion the joy of generosity and a greater sense of purpose."

In 2021, Kaiārahi Trust grew from only six donors to more than 20 and helped facilitate nearly 2 million dollars in grants to a variety of causes.

As an accredited member of the TrustBridge Global Network of Donor Advised Funds, Kaiārahi Trust receives ongoing support, tools, and resources and the ability to make international grants to their favorite global causes.

While the DAF provides efficiency, anonymity, guidance on giving, due diligence, administrative management, and tax advantages, the real reason donors love it is about so much more. "Our donors know it's about expressing who they are," says Robert. "Because no matter how successful someone is, we all want to live a life with purpose and meaning. As a guide for generous givers, we are helping them navigate their journey to impact society and make the world a better place."

Now that's a journey worth taking.

Vice President, Generosity & Network Relations



1. Legal basis and organization

1.1 General

TrustBridge Global Foundation is a stiftung (foundation) established with a deed dated October 6, 2016 under Art. 80 ff. ZGB with its registered office in Thun.

1.2 Purpose of the Foundation

TrustBridge Global Foundation is a Dachstiftung (charitable umbrella foundation) with the purpose of making donations in the following areas:

- a. Health
- b. Education
- c. Poverty alleviation
- d. Promotion of culture and the arts
- e. Promotion of the Christian faith

1.3 Board of Trustees

1.4 Auditors / Supervisory Body

1.5 Tax Status

According to the ruling of the tax administration of the canton of Bern dated January 31, 2020, the foundation for charitable purposes and for religious purposes is tax exempt retrospectively from January 1, 2019. According to Swiss tax law, donations for charitable purposes are fully income tax deductible (subject to upper limits), those for religious purposes are not tax deductible.

1.6 Organization / Donor advised Fund

TrustBridge Global Foundation has the following income:

- Free donations for use in accordance with the purpose of the foundation
- Receipt and administration of donor advised funds in accordance with the contract

Appendix

1.7 Donor advised Fund ("DAF")

A donor advised fund offers a flexible way for donors to give money to charities - an alternative to direct donations or the creation of a private foundation. Donors enjoy administrative convenience (the sponsoring organization takes care of the administration), cost savings and tax advantages (in contrast to individual donations). With the DAF agreement, the funds made available to the foundation become the property of the foundation. The donor can influence the investment and the use of these funds by means of recommendations.

At the end of the year there were various DAFs with with assets of CHF 28,692,630 (previous year: CHF 25,707,677).

2. Information on the principles applied in the annual finanancial statements

The present annual financial statements have been prepared in accordance with the provisions of Swiss accounting law (32nd title of the Code of Obligations).

The following principles were applied in the annual financial statements:

2.1 Foreign Currencies

Bank balances, receivables and liabilities in foreign currency are recorded at the current rate. In contrast to the previous year, the foreign currency stocks on the balance sheet date are no longer converted into the local currency at the closing rate.

The majority of the cash flows are in USD.

2.2 Financial Assets

Financial assets include long-term securities that have the economic character of long-term investments and long-term loans to third parties.

Financial assets with a stock exchange price are valued at market value on the balance sheet date.

2.3 Donations Received

Donations received are recognized as income when the money is received.

The loan to Ferma Naturala Heritage Srl was earmarked for the development of an organic garden. The term of the Ferma Naturala loan has been extended from 09/30/2021 to 09/30/2022 due to COVID.

The loan to PT Island connections is for capital investment. It is unsecured and pays 5.0% interest. Due to the COVID-19 pandemic, the loan terms were changed in the reporting year so that the interest due dates were redefined and the term was extended by 1 year to July 25, 2025.

The Joma shares were donated to another charity (Impact Foundation in the US) on June 5, 2021.

The loan to Quo Vadis Institut in EUR was granted specifically for the acquisition of a property. The loan is secured by a mortgage on the financed property. It bears no interest and has an indefinite term granted. The loan in USD was earmarked for the renovation of this property, on the same terms as the first loan to finance the purchase price.

The loan to Ebenezer Trust was earmarked for the education and support of young people in the agricultural sector. The loan is unsecured, bears 6% p.a. interest and is due for repayment by July 18, 2023.

The loan to Pureflow Initiative Ltd. is dedicated to expanding its anti-poverty program, which specifically allows motorbike taxi drivers to own their vehicles instead of renting them constantly. The loan is unsecured, bears interest at 7.0% p.a. and is due for repayment on November 30, 2025.
