LETTER FROM

THE CEO



I am grateful for your achievements with and through TrustBridge. In this annual report, you will see numerous metrics of TrustBridge's progress, but please remember that behind each number is a life that is impacted for good. We have captured some of those stories, but there are thousands of untold stories for every one we know. Here are our key results:

Donor and Charity Experience: In 2022, donors and charities gave TrustBridge a Net Promoter Score of 83%, which is super high. While this score is almost mathematically impossible to improve, we continue to focus on improving the experience of giving and receiving through TrustBridge.

Expanded Reach: In 2022, TrustBridge added two new Network Members and is now in 11 countries. Since inception, TrustBridge has made 2,700 grants to 900 charities in 90 countries totaling SFr 250 million. Total grantmaking is up 63% in just one year – thanks to you!

Innovative Solutions: TrustBridge has just launched GivingSpace, an online charity marketplace built to support giving collaborations. If you give globally in collaboration with others, please check out GivingSpace and start your own group!

Financial Stewardship: TrustBridge has disciplined and responsible financial management, with 97.8% of our total expenses being allocated to outgoing grants. Our goal is to eventually get to over 99% efficiency.

As we look to the future, our focus remains on serving you: TrustBridge's mission is to mobilize resources by making global giving easy for you. We will continue to serve donors and charities well, build our global network, invest in new projects, and forge strong partnerships all to serve you better.



FOUNDATIONS FOR FARMING

Foundations for Farming is an NGO based in Zimbabwe, specializing in training small scale farmers in all aspects of sustainable agriculture. FfF's mission is for all farmers to become self-sufficient and escape poverty while protecting and improving the environment and transforming their lives.

So far, FfF has directly trained more than 30'000 farmers and instructors, and its principles have been taught to more than 3 million farmers around the world. FfF-trained farmers do not get handouts, as they themselves, their knowledge, and skills are the investment that aims to break the cycle of dependency in poor communities.

FfF was awarded the inaugural Partnership Award in 2022 by the Food and Agriculture Organization of the United Nations (FAO), for training all Government of Zimbabwe agricultural extension officers and bringing food security to 9-million Zimbabweans during the COVID-19 pandemic lockdowns.

Being at the bottom and finding success can provide hope and lessons to the world. Hope grows in the fields of Africa.



GEORGE WHITEFIELD **COLLEGE**

George Whitefield College was founded by the Reformed Evangelical Anglican Church of South Africa (REACH SA) in 1989. Seeking to play a role in equipping the current and future leaders of the church in Africa, the GWC community represents up to 15 African and worldwide nationalities and multiple evangelical denominations, making GWC an extraordinary place to study. Over 600 GWC alumni serve in church leadership in many countries in Africa and around the world.

GWC is currently supported by 37 staff and faculty members. The college is developing its digital resources to enable hybrid attendance and access to its library of 60,000 volumes; as well as its funding capabilities, to provide access to training for underprivileged students.

The Farsi word, Panahgah means a safe place of refuge, and for the Afghans who hear of Panahgah it means an opportunity to seek refuge away from the hostilities of their home country. Panahgah is a Brazilian non-governmental organization offering vulnerable, persecuted, and stateless people a chance at a new life in Brazil.

Since 2021, Panahgah has helped resettle Afghan families in different cities across the country with the help of local churches, their communities, and the Brazilian government. In 2022, Panahgah was able to resettle many families seeking refuge, many of whom were able to establish permanent domicile for the first time in many years and begin planning for a stable future.

The Lebanese Society for Educational and Social Development (LSESD) serves the Middle East and North Africa region by providing support in three key-areas of social development:

- 1. Addressing the basic needs of vulnerable families, especially refugees and those affected by the violence in neighboring countries, in a manner that preserves their dignity.
- 2. Reducing the future vulnerability of students with learning difficulties, by providing them with educational support.
- 3. Training socially responsible Arab Christian leaders who take an active role in society.

Today, it is estimated that one in three people in the MENA region is a refugee -Syrian, Iraqi, Palestinian or other. Through their work, LSESD carries a message of hope and encouragement to all those in need.

Appendix

1. Legal basis and organization

1.1 General

TrustBridge Global Foundation is a stiftung (foundation) established with a deed dated October 6, 2016 under Art. 80 ff. ZGB with its registered office in Thun.

1.2 Purpose of the Foundation

TrustBridge Global Foundation is a Dachstiftung (charitable umbrella foundation) with the purpose of making donations in the following areas:

- a. Health
- b. Education
- c. Poverty alleviation
- d. Promotion of culture and the arts
- e. Promotion of the Christian faith

1.3 Board of Trustees

1.4 Auditors / Supervisory Body

1.5 Tax Status

According to the ruling of the tax administration of the canton of Bern dated January 31, 2020, the foundation for charitable purposes and for religious purposes is tax exempt retrospectively from January 1, 2019. According to Swiss tax law, donations for charitable purposes are fully income tax deductible (subject to upper limits), those for religious purposes are not tax deductible.

1.6 Organization / Donor-advised Fund

TrustBridge Global Foundation has the following income:

- Free donations for use in accordance with the purpose of the foundation
- · Receipt and administration of donor advised funds in accordance with the contract

1.7 Donor-advised Fund ("DAF")

A donor-advised fund offers a flexible way for donors to give money to charities - an alternative to direct donations or the creation of a private foundation. Donors enjoy administrative convenience (the sponsoring organization takes care of the administration), cost savings and tax advantages (in contrast to individual donations). With the DAF agreement, the funds made available to the foundation become the property of the foundation. The donor can influence the investment and the use of these funds by means of recommendations.

At the end of the year there were various DAFs with assets of CHF 23,625,431 (previous year: CHF 28,692,630).

2. Information on the principles applied in the annual finanancial statements

The present annual financial statements have been prepared in accordance with the provisions of Swiss accounting law (32nd title of the Code of Obligations). The following principles were applied in the annual financial statements:

2.1 Financial Assets

Financial assets include long-term securities that have the economic character of long-term investments and long-term loans to third parties. Financial assets with a stock exchange price are valued at market value on the balance sheet date.

2.2 Donations Received

Donations received are recognized as income when the money is received.


